Prince—Mrs. Estella B. Prince, age 46, one of Jackson county's most prominent women, passed away at the St. Joseph hospital at Louisville Friday morning at six o'clock.
Mrs. Prince had been suffering with an abdominal tumor for some time. About five weeks ago her suffering became so intense that on July 23rd, she was taken to the St. Joseph hospital, where she underwent an operation Thursday, but due to her weakened condition, she could not withstand the shock from the operation.
