Dickie Joe Robison, 72, of Brownstown, Indiana, passed away at 4:20 p.m. Friday, April 19, 2013 at Norton Hospital, Louisville, Kentucky.

Dickie Joe had retired from Duke Energy after 32 years of service, and also worked at Swifty Farms for 14 years. He was a U.S. Army veteran who served with the 25th Infantry Division based at Honolulu, HI. He was a member of American Legion Post 89 of Seymour, a member of the American Quarter Horse Association of Indiana. In addition he was an avid sports fan who played basketball for the Brownstown High School Bears. He also had been a member of the U.S. Army Division Basketball team while stationed in Hawaii.



Born April 26, 1940 in Ewing, Indiana, he was a son of the late George W. and Myrtle McKinney Robison. On March 19, 1966 in Rising Fawn, GA, he married Carolyn Brooks who survives.
