

MRS. IDA T. ALLEN DIES AT BROWNSTOWN

Funeral Services Conducted Today for Wife of Sherman Allen—Was Well Known.

Funeral services were conducted at 2 o'clock this afternoon from the home in Brownstown for Mrs. Ida T. Allen, wife of Sherman Allen, of Brownstown. The Rev. Frank Templin, paster of the Brownstown Methodist Church, was in charge and burial was in Fairview Cemetery at Brownstown.

Mrs. Allen, who was seventyseven years of age, died at 3:20 o'clock Saturday afternoon at the home in Brownstown follow-

ing an illness of two weeks' duration. She had been in ill health for the past three years.
