Cortland Area Man Killed In Two-Car Crash

Funeral Rites Held Monday
For Montgomery Allman
—Burial Rites in Fair-
view Cemetery in Browns-
town.

Burial rites were held in Fairview Cemetery here, following funeral rites from the Voss Chapel in Seymour for Montgomery Allman, 68, Cortland R1, who was injured fatally in a two-car crash early Friday afternoon at a rural road intersection northwest of Cortland.

Mr. Allman, who died of internal injuries, was driver of one of the cars involved.

Riding with him was his sister, Miss Anna Lucille Allman, 43, of Cortland R1, who suffered multiple contusions and abrasions and was treated at the Jackson County Schneck Memorial Hospital.

Also admitted to the hospital was Jerry L. Chastain, 20, Medora R1, who was driving the other car involved. He suffered a laceration below his nose and forehead abrasions.

According to Seymour State Police Trooper R. T. Acton, Mr. Allman was operating his automobile west on County Road 800N, and, according to the officer stopped at a "yield" sign at blacktop Road 100E, then started to turn left on the blacktop, driving into the path of the car driven north on Road 100E by Mr. Chastain.

The Allman auto was torn in two by the impact.

The officer said seat belts were not being used by Mr. Allman, but had they been they would not have prevented his death. However they might have minimized the injuries suffered by his passenger.

Both cars were totaled.

Mr. Allman, known to his friends as "Num" was born in Hamilton township, September 18, 1901, a son of the late Joseph Allman, Sr., and Mollie Hiten Allman.

He was a farmer and lived all of his life in Hamilton township.

He was married in 1919, in Louisville, Kentucky, to Carrie Kinworthy, who died in 1965.

Three daughters also are deceased.

Surviving are two brothers, Herbert L. Allman, of Seymour; and Joseph S. Allman, Cortland R1; five sisters, Mrs. Mary Lucas, of Acme, Miss Nancy Allman and Miss Lucille Allman, Cortland R1, Mrs. Gladys Davidson, Seymour R2, and Mrs. Betty Malone, Seymour R2.

Two brothers, a sister, a half-brother and a half-sister also are deceased.

The funeral services was in charge of the Rev. Dennis Croucher, pastor of the Woodstock Pentecostal Church, at Seymour.
