## Attorney Frank M. Vance died at the Hatfield House Monday night," of acute Bright's disease, following an d illness of less than twenty-four hours. He had been in poor health for several months, suffering from periodical attacks of kidney trouble, and his last illness was the acute exaserbation of the old trouble. For the past two weeks he had complained often to his friends of his poor health and had planned to start on a trip to the southwest July 1st to recuperate and try to regain his health. Sunday evening at 8 o'clock he was stricken with his last illness and was removed to the Hatfield House. His condition through that night and all day Monday was such that little hope was entertained for his recovery. His father, Capt. D. B. Vance, of Brownstown, was notified by wire and was brought to this city in an auto-

was brought to this city in an automobile, arriving here at 2:30 o'clock Monday afternoon. When Capt. Vance reached the bedside his son recognized him with 'Hello Dad' and after a few words spoken lapsed into a semi-unconscious condition, which continued until death. His mother arrived at 7:20 over the Southern Indiana, just a few minutes too late to see her son alive.

Mrs. F. M. Vance, who was visiting her brother in Denver, Colo., was notified Monday afternoon of the dangerous illness of her husband and left for this city at 9 o'clock that night before the message announcing the death of Mr. Vance reached that place. Her brother, Robert Hinderlider, of Bloomington, left Tuesday, for St. Louis, where Mrs. Vance arrived at 7 a. m. Wednesday morning, to break the news and accompany herto Browns town. Mrs. Vance has been in poor health for some time and it is feared that the news of her husband's death. together with the hours of suspense suffered, will cause a serious nervous breakdown.

Frank M. Vance was the son of Capt. and Mrs. D. B. Vance, of Brownstown. He was born in Crothersville, Jackson county, 31 years ago last December. His parents moved to Brownstown when he was four years of age, where before his majority he began his study of law in the office of Burrell & Branaman. He later graduated from the Indiana Law school at Indianapolis, and was reading law in the office of Albert J. Beveridge at the time that statesman was elected for the first time to the United State Senate

He was admitted to the Lawrence s county bar and located in this city e early in the spring of 1901.

On May 28th, 1901, shortly after establishing a law office in this city Mr. Vance was united in marriage to Miss Fannie Hinderlider, daughter of Mr. and Mrs. David P. Hinderlider, of Medora.

In his eight years sojourn in this city Mr. Vance had built up a large law practice and was recognized as one of the ablest criminal lawyers in this section of the State. By his unselfishness and warmness of heart he had endeared himself to his friends, who are appalled at his untimely death.

He was a member of the local I. O. O. F. and B. P. O. E. orders.-Bedford Mail.

The remains were taken to Brownstown Wednesday forenoon and the funeral will be Thursday. The hour of the funeral will be fixed after the arrival of Mrs. Vance.
